ADDENDUM
E-VERSION OF JAFZA LETTERS

The E-Version of Jafza Letters includes:

- Letter Content
- Electronic Stamp
- Reference number for EDV (Electronic Document Verification) online verification
- EDV (Electronic Document Verification) web address

I. EDV (Electronic Document Verification)

EDV is an **online verification facility** for the Jafza Letters to Immigration – E-Version, by using the EDV code in the e-version letter and inputting additional required fields and clicking the button “Verify Document”. It is a web-based verification tool for ensuring the authenticity of Jafza letters.

On **successful verification**, the EDV screen will prompt a message “Document Verified”, and a “View Document” button will be made available as an additional verification option, upon clicking, a copy of the issued letter will be displayed on the screen for the visual comparison.

Unsuccessful verification the EDV screen will prompt a message “Document not verified”.

II. Process

1. What is EDV for?

EDV is a verification channel for the use of **external** agencies, now they can verify Jafza Letters over the internet using the electronic code in the EDV page without contacting Jafza Administrative Services Department for telephone verification.

2. How do we go to the EDV page?

The EDV link can be seen in the lower section of the issued letter.

3. How do we (external agencies) validate the Jafza letter in our hand using EDV?

a. EDV requires the verifier to enter 3 parameters:

- **EDV Number** – this is the code number indicated in the Jafza letter.
- **Issue Date** – The date indicated in the Jafza letter.
- **Passport Number** – The passport number indicated in the Jafza letter.

b. Click “**VERIFY DOCUMENT**”

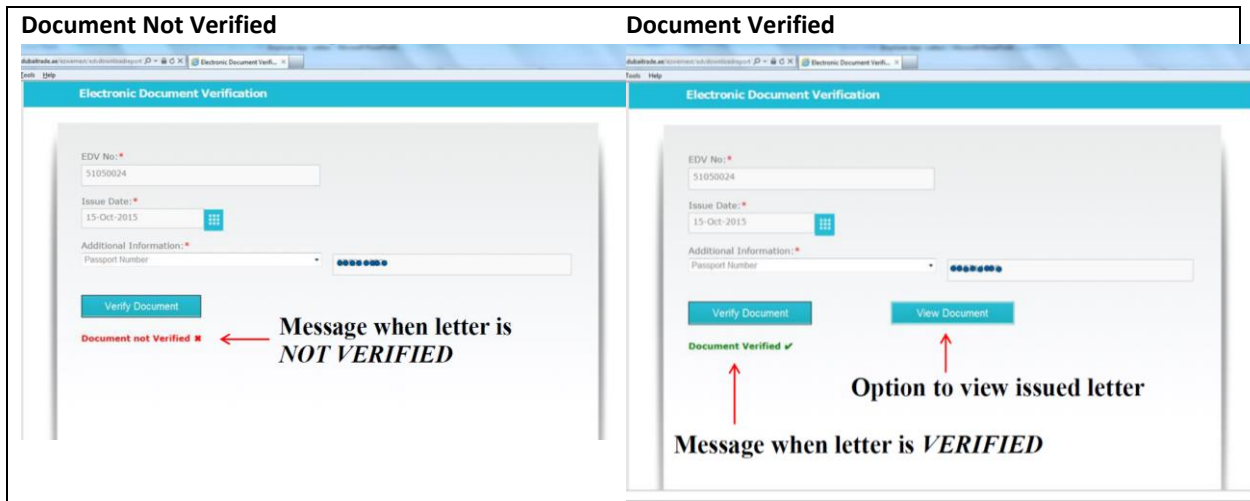
- EDV No.:** A text input field with a red arrow pointing to it and the instruction "1. Enter: EDV No."

4. How do we know if the letter is valid or not in EDV?

Upon Clicking “**VERIFY DOCUMENT**”, a message will appear if the letter is successfully verified or not:

- **DOCUMENT NOT VERIFIED** – message will appear below the verify document for **unsuccessful** verification of the document.
- **DOCUMENT VERIFIED** – message will appear below the verify document for **successful** verification of the document.

On successful verification, the “**VIEW DOCUMENT**” will appear, this is an optional feature that the verifier can use. Upon clicking this button, a copy of the issued letter will display and the verifier can visually compare the online letter copy from the hard copy on had with the verifier.



5. Does Jafza acknowledge this electronic letter as one of their official letters?

Yes, Jafza recognizes the electronic version of their letters as official.

6. How long is the electronic letter valid?

Electronic letter version is valid for 30 days from the date of issuance. After that the letter will be invalid and when used in EDV it will give a **DOCUMENT NOT VERIFIED** message.
