
Amend Employee Details in Employment Visa



Definition

An Entry Permit Correction is a process that enables the client to correct any errors/incorrect data found in the Entry Permit issued before the employee arrives in UAE.

Cancel Unutilized Employment Visa




Definition

- Employment Visa is an Entry Permit which is required for a person to enter the UAE.
- Employment Visa is a precursor to obtaining a Residence Permit.
- A Jafza customer can request to cancel an unutilized employment visa entry permit.
- The Employment Visa Entry Permit will be cancelled from company record. The availed visa quota will be reduced. The refund shall be topped-up in company portal account based on eligibility.




New Employment Visa



Definition

- Employment Visa is an Entry Permit which is required for a person to enter the UAE.
- Employment Visa is a precursor to obtain a Residence Permit.
- Minimum age limit for Employment Visa is 18 years.



* (Employment Visa is valid for 2 months from the date of issue and will be sent to the customer either through Courier or can be picked up over the counter as requested while submitting the request.)



Required Documents to upload

- Two Latest Colour Photographs for GDRFA (4.5 X 3.5)
- Two passport copies
- Labour Cancellation paper copy to be submitted if the applicant is inside UAE on earlier Residence visa
- Company Immigration Card (CIC) copy
- Bank Guarantee/Cash Guarantee (1.5 * Monthly Basic Salary + One way IATA (International Air Transport Association) Air Fare to the Country of Origin).



Fee

- AED 2,700: (Entry Permit, Company Employment Card, Normal *Medical Test and Residence Permit Stamping)
- AED 100: GDRFA Application Fee (included)
- AED 90: for EIDA Application Schedule (included)
- AED 160: (Entry Permit Urgent Additional)
- AED 100: New Employment Contract Attestation (will be deducted additional at the time of arrival intimation to process the Residence Permit)
- AED 780: If the applicant is inside UAE at the time of applying for Employment Visa (Additional)
 - * VIP Service package' Additional charged applicable

Issue Original Employment Visa to Enter UAE Through other than Dubai Airport



Definition

- The General Directorate of Residency and Foreign Affairs (GDRFA) permits the online entry permit holders to arrive through Dubai ports.
- In case the applicant is arriving through any other ports in UAE other than Dubai, the applicant need to obtain the original Entry Permit ("Pink Copy").




Obtain Entry Stamp in Employment Visa to Avoid Exit



Definition

- Obtain Entry Stamp in Employment Visa to Avoid Exit will facilitate the employees to get the Airport Entry Stamp on the Employment Visa and passport without leaving the country.
- This service is applicable only to employees who obtained an Employment Visa while he/she was inside UAE.
- Not applicable, if applicant on a Tourist visa or overstayed.



* Visa Status Amendment stamp by GDRFA on the Entry Permit & Passport. The documents will be delivered based on selection of documents collection / delivery by customer at the time of request creation.



Required Documents

- Visa Status Amendment Form Form 3 (www.jafza.ae).
- Entry Permit Employment Visa Electronic Copy.
- Visit Visa Copy or Original Residence Permit cancellation.
- Original Passport.
